



# PINNACLE 12V LED GARDEN SPOTLIGHT – SINGLE HEAD 19921/06 BLACK

Before first using your new Brilliant Pinnacle garden spotlight it is most important that you read and follow these instructions, even if you feel you are quite familiar with this type of product. Keep this document handy for future reference.

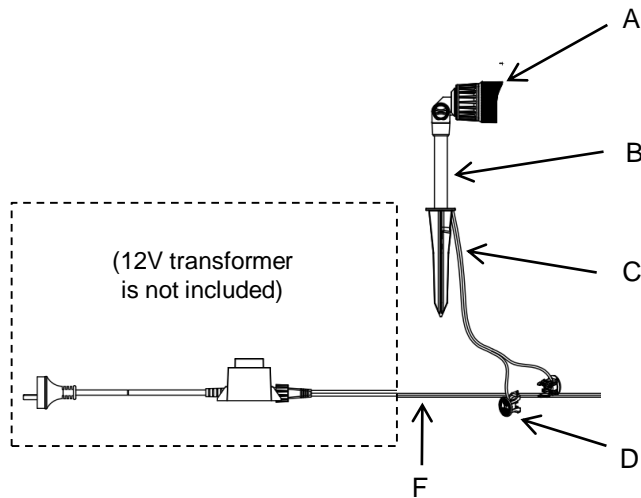
### CAUTION:

- If you are in any doubt as to the installation of this product, please consult a qualified electrical contractor before proceeding.
- This product works on 12V AC/DC extra low voltage.
- Total wattage of lights must not exceed the wattage of the power supply
- There are no user serviceable parts within this kit.
- When drilling into the surfaces into which the lights are to be mounted, care must be taken to ensure you do not damage electrical wiring and other hidden utilities.

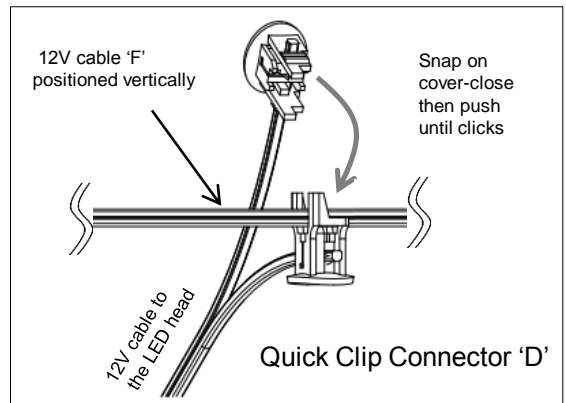
## DIY Installation

### INSTALLATION:

1. Assemble garden spike by inserting stick 'B' into light head 'A' and inserting spike 'C' into stick 'B'.
2. Select the location for the spike spotlight and determine the cable that you need and the position of quick clip connector 'D'. If installing more than one spike spotlight determine all locations prior to installing connectors.
3. Attach your LED spike lights 'A' to the 12V cable 'F' via quick clip connectors 'D'. Refer to the connection details. Ensure to place the 12V cable 'F' into the connector vertically then push the connector cover until it locks.
4. Plug your 12V cable 'F' to 12V transformer (not included) and switch on power. Your 'Pinnacle' garden spotlight will operate automatically.
